Appendix 1, Instructions and explanations

Information provided in the Certificate Request (on page 1) is validated and appears in the EV SSL certificate. The numbering below corresponds to the numbering on the Certificate Request form.

Part 1: Applicant Information (this information will be included in the Certificate)

- 1. Organisation Name (Legal Name):** Provide the Applicant's formal legal name as recorded with the Incorporating Agency (for private organisations) or as specified in the law (for government entities) of Applicant's Jurisdiction of Incorporation. NOTE: this name must exactly match the Subject Name in the CSR provided to DarkMatter.
- 2. Domain Name (URL to be secured):** Provide the fully qualified domain name to be included in the EV Certificate (for example, www.darkmatter.ae or secure.darkmatter.ae). The EV vetting process must determine that the Applicant is either the Registered Holder of the domain, or has been granted exclusive use of the domain by the Registered Holder of the domain name.
- 3. Applicant Address Details:** Provide the street address of the Applicant's Place of Business. This must be a physical address (not a P.O. Box, mail drop, or agent's office) where the Applicant conducts business and that can be verified in public records and/or third party databases.
- 4. Jurisdiction of Incorporation:** Provide the Applicant's Jurisdiction of Incorporation to be included in EV Certificate, and consisting of City or town (if any), State or Province (if any), and Country.

- 7. Confirming Person:** Must be a corporate executive or legal counsel of the Applicant whose position can be verified using official records. Verification cannot be performed by reference to the Applicant's websites or promotional materials. The Confirming Person must sign a completed Authority Letter to establish the identity and authority of the Contacts acting for the Applicant.

Part 3: Approval Contacts

There are three roles involved in the EV application, which must be filled by named individuals. An Applicant may authorise one person to fill all three roles, or more than one person to fill each role.

- 8. Certificate Requester:** Submits the Certificate Request and is the primary contact for certificate installation. The EV Certificate Request must be completed by an authorised Certificate Requestor. May be an employee of the Applicant or a third party (such as a consultant or ISP) acting for the Applicant.
- 9. Certificate Approver:** Approves all Certificate Requests and is contacted if further information is required to process the Certificate Request. Must be an employee of the Applicant.
- 10. Contract Signer:** Approves the Subscriber Agreement and other contractual obligations on behalf of the Applicant. Must be a duly authorised employee of the Applicant.
